

Cabinet and Governor Appointed Agencies' Performance Audit Action Item(s) & Status

Barriers to Home Care Aide Certification

(See also cabinet agency response for full context to Washington State Auditor's Office (SAO) report, November 2016)

The Departments of Health (DOH) and Social and Health Services (DSHS) were included for this performance audit.

SAO Conclusion: Although the agencies (DSHS & DOH) and their partners have made improvements to the process since the implementation of Initiative-1163, some applicants still face barriers and drop out of the process.

SAO Issues Summary:

1. Stronger efforts to make it easier for applicants to complete the process, such as making access to training and the exam more accessible and addressing challenges for limited English proficiency applicants, could improve completion rates for the home care aide certification program.

SAO Recommendations (Rec) Summary:

- 1. DOH and DSHS work with the Training Partnership to review data on the languages applicants request interpreters for to determine if they need to expand the number of languages currently available for training and the exam.
- 2. DOH and DSHS work with their partners to emphasize the importance of taking the exam on the scheduled date.
- 3. DSHS continue to work with the Training Partnership and community instructors to increase training locations and adopt flexible schedules.
- 4. DOH work to reduce the distances applicants have to travel by working with its test provider, Prometric, to increase the number of testing sites in the state.

Instead of asking "What is your primary language?" they are now asking "what language do you speak at home?" and what language do you read in?" They found that when they asked "What is your primary language" that the student thought since they were living in the USA that they had to say English. They believe this new approach may be more effective in getting the student into the right course for better success. They have also mapped the learning journey for the LEP learner to identify pain points and opportunities for improvement and are providing this to agency employers to use as a resource. Due to increased demand DOH and Prometric are now offering the exam in Amharic.

The Training Partnership is also continuing to train their in house instructors and their subcontractors on how to use the checklist to make sure they inform their students of all the required steps and timelines accurately and effectively.

This also should assist candidates to obtaining training and their Home Care Aide Credential within their deadline.
