

## Cabinet Agencies' Performance Audit Action Item(s) & Status

## The Experiences and Perspectives of Washington Families who Adopted Children from Foster Care

Agencies included in the performance audit: the Department of Social and Health Services (DSHS).

## SAO Recommendations (Rec) in brief:

- 1. Develop a plan for enhancing post adoption services for families adopting foster children using the parent survey results and information from other states.
- 2. Reach out to parents one year after the DSHS finishes centralizing the adoption support program to determine whether their satisfaction with the unit's performance and its consistency has improved and report the results of its analysis to the Governor and the Legislature after the outreach is completed.

One area described by the parents was the need to improve availability of adoption competent public and private professionals who work with adoptive families. Training for social service staff and community professional who provide treatment to adoptive children and families was also described as a need.  Support provided by the National Training Institute, Center for Adoption Support Education, and the Children's Bureau.  Washington State was selected as a pilot site for a web-based training for staff and mental health providers who work with children who are to achieve permanency through guardianship and adoption. The initial training phase will begin Jan 1, 2017 and will involve training adoption, adoption support, Relative Guardianship liaisons, home study licensors, six staff from Coordinated Care of Washington that focus on care coordination for adoption support youth and Program and Policy.
