

Cabinet Agencies' Performance Audit Action Item(s) & Status

Department of Labor & Industries Prescription Drugs

Agencies included in the performance audit: Department of Labor & Industries.

SAO Issues Summary:

- 1. State law requires, and L&I is using, several leading practices to control prescription drug expenses.
- 2. By updating its prescription drug prices, L&I could have saved \$7.1 million in Fiscal Year 2009. It has not followed other practices that could further reduce costs.
- 3. Mail order pharmacies.
