









Small Business Export Assistance



- 5,296 service requests since 2012 (796 in FY2016)
- 1,536 unique companies assisted since 2012 (346 in FY2016)
- \$1 billion in export-assisted sales (\$265 million in FY2016)
- \$27 million in estimated tax revenue from Commerce-assisted export sales
- 52 Commerce-led delegations to trade shows and trade missions for a combined 641 attendees (13 delegations in FY2016)



SBA State Trade and Export Promotion Grant



Washington State recognized by SBA for outstanding return on federal taxpayer investment during STEP FFY 2014 (Year 3)

- Average \$190 in reported export transactions per federal STEP dollar awarded (compared to an average \$37 for all other STEP grantees)
- Washington led the nation in cumulative assisted export results for the first three years of the STEP program (the only years that data has been released by SBA to date)
